THE FOLLOWING CITIZENS CAN REGISTER:

- a) ITALIAN CITIZENS
- b) CITIZENS OF THE EUROPEAN UNION REGARDLESS OF WHERE THEY RESIDE
- c) NON-EUROPEAN UNION CITIZENS THAT OFFICIALLY RESIDE IN ITALY (in accordance with art. 26 of Law n. 189 of 30/07/2002)
- d) NON-EUROPEAN UNION CITIZENS LIVING ABROAD THAT HAVE APPLIED FOR A STUDY VISA

FOR CITIZENS THAT CORRESPOND TO CATEGORY a), b) AND c), NO CERTIFICATION REGARDING ITALIAN LANGUAGE ABILITY IS REQUIRED, WHILE FOR CITIZENS THAT CORRESPOND TO CATEGORY d) PROOF OF ITALIAN FLUENCY IS COMPULSORY, APART FROM IN THE SITUATIONS OUTLINED IN POINT I.2 OF THE "MINISTERIAL PROCEDURE IN FORCE FOR THE 2020/21 ACADEMIC YEAR" which can be consulted on the MUR website at the following link: <http://www.studiare-in-italia.it/studentistranieri/>. Candidates who have failed the Italian language test will not be admitted to further exams contained in the Call.

HAVING SATISFIED THE APPLICATION REQUIREMENTS, CITIZENS THAT BELONG TO CATEGORY a), b) AND c), WILL BE INCLUDED IN THE SAME RANKING LIST AS THE STUDENTS WITH ITALIAN ACADEMIC QUALIFICATIONS.

THE CITIZENS WHICH CORRESPOND TO POINT (d) SHALL BE INCLUDED IN THE SELECTION LIST UP TO THE NUMBER OF PLACES AVAILABLE FORESEEN IN THE BAND FOR THIS CATEGORY AND IN LINE WITH THE MINISTERIAL DECREE IN FORCE, WHILE, IF THEY ARE IN POSSESSION OF A QUALIFICATION MENTIONED IN ANNEX 2 OF THE "INTERMINISTERIAL PROCEDURES IN FORCE FOR THE 2020/21 ACADEMIC YEAR, THEY WILL BE INCLUDED EXTERNAL TO THE NUMBER OF POSITIONS RESERVED FOR NON EUROPEAN UNION CITIZENS LIVING ABROAD THAT HAVE APPLIED FOR A STUDY VISA.
